The European Commission has launched a EUR 2.5 million Call for Proposals to support Civil Society Organisations (CSOs) throughout Cyprus!

DEADLINE EXTENDED UNTIL 28 APRIL!

The eighth *Cypriot Civil Society in Action* grant scheme aims at supporting civil society in enhancing trust, dialogue, and cooperation and in promoting European Union values and standards through actions that contribute to promoting the reunification of Cyprus. Since 2007, the European Commission has launched seven Cypriot civil society in action calls for proposals, for a total amount of EUR 14 million and one thematic call for proposals Together against Trafficking in Human Beings for EUR 1 million.

New Agreement for the EU Scholarship Programme

The European Commission and the Goethe-Institut e.V. signed an agreement with a budget of €5 million to implement the EU Scholarship Programme for the Turkish Cypriot community, funded under the Aid Programme, which aims to facilitate the reunification of Cyprus.

The agreement with the Goethe-Institut reinforces the Commission's commitment to bring Turkish Cypriots of different ages and backgrounds closer to the EU, through the life-changing experience of mobility, while facilitating contact with other EU citizens. Building on the successful implementation of the previous actions, the programme will seek to provide even more opportunities for Turkish Cypriots' personal, social and professional development beyond their scholarship, in an effort to contribute to the overall Read more here.

Role of Women in Science

The European Commission with the contribution of the Committee on Missing Persons in Cyprus (CMP) promoted gender equality and celebrated women's achievements during a bicommunal webinar entitled "Role of Women in Science" held on Wednesday, 9 March 2022, within the context of International Women's Day.



In her opening remarks Judit Rozsa, Director for Coordination, Resources and Aid Programme at European Commission, DG Reform, emphasised that the EU hope to be able to contribute to attracting more women to science-based careers, by encouraging future generations and continuing the good work for gender equality in Cyprus, the EU and beyond. She also added that in Cyprus, the EU has just launched a bicommunal call specifically encouraging bicommunal scientific research projects and more information can be received through the Civic Space.

As part of the EU Aid Programme for the Turkish Cypriot community, the EC has been supporting a series of activities and actions to strengthen the organisational capacities, outreach and impact in promoting and defending fundamental rights and women's rights in particular.

Walk through Tulipa Cypria and Maronite Culture

A "Walk through Tulipa Cypria and Maronite Culture" took place in Kormakitis (Kormacit) / Koruçam Village on Sunday, March 20, 2022, from 10:00 to 14:00. The event was organised within the scope of the Healthy Lifestyle 4 All Campaign, carried out with the support of the European Commission.



The event was launched in Kormakitis (Kormacit) / Koruçam Village Square Amphitheatre with an informative presentation on "Tulipa Cypria / Medoş Tulip", one of the endemic treasures of Cyprus, delivered by Hasan Sarpten, President of the Cyprus Turkish Biologists Association for Research and Protection of Nature. Followed by a 2-hour walk towards the tulip valley passing through the streets of Kormakitis (Kormacit) / Koruçam which reflect the Maronite culture. During the walk, the participants were provided with information on Tulipa Cypria/Medoş Tulip, the local flora and fauna, and the natural richness of the island was highlighted.

In his opening remarks, Mr. Alain Joaris, Head of Cooperation at the European Union Programme Support Office talked about the EU General Data Protection Regulation (GDPR) which was introduced in 2018 and set the standard for the global community on data protection. "In the digital age, everything a person does online generates or implicates data that can be highly revealing about their private life. Comprehensive data protection laws are essential for protecting human rights, including the right to privacy," he said.

The European Union has allocated over 5 million Euros for the science laboratories project aimed at supporting the Turkish Cypriot community in the field of science education at primary and secondary school levels. The Science bus, which was officially handed over to the Turkish Cypriot community by the European Commission last year, will allow students from 30 schools that do not have laboratories, to gain the same practical science skills as their peers.


